## Publications

All accepted conference papers will be included in the conference book supplied with ISBN number. The publication will include abstracts of the papers with Conference CD including full papers. The book with CDs will be distributed to all participants during the conference.

After the conference all papers will be considered for publication in one of the following reviewed academic publication:

- ***Oeconomia Copernicana*** – a periodical that is published by Polish Economic Society Branch in Toruń. The Journal is included in following international bases: **ProQuest, RePec, International Copernicus Index, Versita**
- One of reviewed books that will be published after the conference.

All papers will be reviewed for the above publications following their normal review criteria. The acceptance of a paper to the conference is not a guarantee of publication in the journal or publication in a book.

These publications will be prepared after the conference.

## Registration and Conference Fee

The registration will take place:

- a. **early registration - 1 January 2013** - in the case of positive reviews and good cooperation between the author and conference organizers, the authors registering before 1 January have the opportunity to publish articles before the conference. However, due to the process of reviewing of the papers, the organizers cannot guarantee that all the papers submitted in early registration will be published before the conference.
- b. **late registration – 1 March 2013**
